We kindly ask you to complete the tasks that are listed in this roadmap (including the <u>evaluation sheet</u> concerning the website) before the <u>17th</u> <u>of August</u>. Please note that some of the tasks listed in this Roadmap concern only those of you who have not already completed them. If you do not think you will have the capacities to complete some of the tasks listed in the roadmap, please inform the secretariat.

- 1. Provide a list of signatories particularly active in the work with the Charter*(at least 2 if there are more than 15 signatories in your country)*, that would be good examples to share on the website
- 2. Send material/information on at least 1 implemented activity/project from signatory in your country (the information should be quite extensive, an action plan does not count as an example of a good practice)
- 3. In view of the Webinar on the 5th of September, please prepare information on how your national association is working to support the European Charter for equality and how (through trainings/seminars/conferences?)
 - If your national association is <u>not</u> working with the Charter, what are the main reasons for this? (lack of financial resources?, lack of human capacities?, please explain)
- 4. Describe the main difficulties that local and regional authorities in your country face in their work implementing the European Charter for Equality
- 5. Please answer the <u>evaluation sheet</u> (please see next page) of the Observatory website
